TRISCUIT PURPOSE SWEEPSTAKES OFFICIAL RULES

NO PURCHASE OR SCAN NECESSARY TO ENTER. MAKING A PURCHASE OR SCANNING WILL NOT INCREASE AN ENTRANT'S CHANCES OF WINNING.

1. **PROMOTION PERIOD:** The Sweepstakes begins at or about 12:00 AM (midnight) Eastern Time ("ET") on November 1, 2023, and ends at 11:59:59 PM ET on December 31, 2023 ("Sweepstakes Period"). The Sweepstakes Period is comprised of eight (8) entry periods (each, an "Entry Period") as set forth below:

Non-winning entries made in an Entry Period <u>will</u> carry forward to subsequent Entry Periods. The Administrator's computer is the Sweepstakes's official clock.

2. ELIGIBILITY: This Sweepstakes is open only to legal United States residents of Michigan who are at least eighteen (18) years old at the time of entry. Employees, officers and directors of Sponsor, Administrator, HMT Associates, Inc. and any of their respective owners, parent companies, affiliates, subsidiaries, representatives, advertising, promotion and production agencies or agents (collectively, the "Sweepstakes Entities") as well as the immediate family members (defined as including spouse; biological, adoptive, and/or step-parents, grandparents, siblings, children and grandchildren, and each of their respective spouses, regardless of where they reside) and persons living in the same household (whether related or not) of any of the above are not eligible to enter or win. Void outside of Michigan and where prohibited by law. All federal, state and local laws apply.

Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor and Administrator's decisions, which are final and binding in all matters related to the Sweepstakes. Winning a prize is contingent upon fulfilling all requirements set forth herein. Entrants and/or potential winners may be required to provide proof of identification and eligibility as required by Sponsor or Administrator. For purposes of the Sweepstakes, an entrant's residential address and e-mail address will be the physical address and e-mail address submitted at the time of registration. Entrants will not be allowed to change their physical address or e-mail address on a submitted registration. 3. HOW TO ENTER: During the Sweepstakes Period, eligible entrants must visit http://triscuitpurpose.com/ ("Website") and submit their valid e-mail address. An entrant may access the Website directly, or by using a smart phone or other web-enabled device to scan the QR code found on in-store signage. If an entrant chooses to access the Website directly via a mobile device or by scanning the QR code, standard message and data rates may apply in accordance with their mobile service plan. A mobile device is not required to enter. If it is the entrant's first time participating in the Sweepstakes, the entrant must first complete and submit the registration form with all required information, which may include, but may not be limited to, first and complete last name (no initials), telephone number, street address (no P.O. Boxes will be allowed), city, state, ZIP Code, and date of birth. The entrant must then follow the on-screen prompts to watch a short video about Triscuit's partnership to support the Zero Hunger Zero Waste Foundation ("Video"). After registering or (submitting a valid e-mail address on subsequent days) and watching the Video, the entrant will automatically receive one (1) entry into the Sweepstakes.

LIMIT: Each entrant is limited to receiving one (1) entry per day during the Sweepstakes Period. A "day" is defined as starting at 12:00 AM ET and ending at 11:59:59 PM ET on a calendar day during the Sweepstakes Period. If more than one (1) entry per day is received from the same person, telephone number, address, or e-mail address, and no attempted fraud is suspected, only the first entry received may be considered valid. If fraud is suspected by the Sponsor or Administrator, the entrant will be disqualified and all of his/her entries will be declared null and void.

4. RANDOM DRAWINGS: On or about each of the Random Drawing Dates set forth in the chart in Section 1, the Administrator will randomly select one (1) potential winner from all eligible entries received during the applicable Entry Period (each, a "Random Drawing"). Each winner is considered a potential winner pending verification of his/her eligibility and compliance with these Official Rules.

5. PRIZES, APPROXIMATE RETAIL VALUE ("ARV"), AND ODDS OF WINNING:

- a. Prize (8 total, 1 per Entry Period): Each "Prize" is a \$1,000 value retailer gift card. Eight (8) total Prizes will be awarded in the Sweepstakes; one (1) Prize per Entry Period. If, due to a technical, production, human or other error, more than one (1) entrant receives a winner notification for the same Entry Period, the one (1) intended Prize for that Entry Period will be awarded in a random drawing from among all recipients of such notifications. The ARV of each Prize is \$1,000.

Prizes that are unclaimed, unredeemed, or returned as undeliverable will not be awarded.
